Membership Rules:

1. Must have a current address, email address and phone number on file.
2. Must purchase refreshments at the clubhouse. **Carrying in beer/alcohol/hard liquor is prohibited under State Statute §125.32(6).** No beverage bottles or glasses are allowed on the course. (Violators may be asked to leave or restricted from playing; membership may be revoked -- without refund.)
3. Play is not allowed on the course if the facility is not open for business.
4. Tee times can be made in-person, by calling the clubhouse, or through the website.
5. Members and all golfers and riders must check in at the Pro Shop before heading out to the tee box. **NO EXCEPTIONS!** This includes league play.
6. USGA Rules govern all play. Observe the 90-degree cart rule. Out of bounds is defined by white stakes. Water hazards are marked. Ground under repair is defined by white lines.
7. Abide by 'READY GOLF' standards. Golfing should be without delay. No more than a foursome in one group. Let faster groups play through.
8. All golfers must have their own clubs.
9. Appropriate golf attire is required.
10. All golfers must be at least 16 years of age to operate a rented golf cart.
11. No more than 2 persons in a golf cart. **Only 4 persons allowed at one tee time.**
12. Carts must stay on designated paths, obey signs, and not operate any closer than 30 feet from all tees, sand traps, and greens. Drive slowly when entering and exiting a bridge. Do not drive carts between the green and sand traps.
13. Repair all ball marks and divots.
14. Members are responsible for any damage they cause to the course, carts, another's property, or any injury.
15. Golf reciprocals **cannot be used for league play or tournaments.** Member/guest rates do not apply to league rates.
16. Charging privileges are available (daily tabs) with a credit card on file. Cards must be in good standing through December 2026. Delinquent tab accounts will be subject to an interest rate of 2% per month and may result in suspension of the charge account.
17. If your personal golf cart is stored off the course, members must register each cart separately for a trail pass.
18. These provisions are subject to change. Season pass members will receive communication when provisions change.

By signing this application, the Season Pass holder agrees to abide by the provisions set in place by the Lancaster Municipal Golf Course. This signature conveys responsibility for all other members attached to this membership.
